Program Chairman for July, **Bob Bond** introduced his guest speaker, Lisa Hastings, Richmond Director of **Community Development.**

Lisa has only one part time employee doing nuisance abatement. The rest she basically does herself. Mainly involved in enforcement of City Ordinances:

Nuisance Codes, Building Codes, Garage Sale Permits, Planning and Zoning Board Adjustments, New Business inspections and an immense amount of mapping work. The information that impressed me with what all she and one part time person does is listed as follows: (This is a yearly average over the past five years.)

125 permits for construction and renovations 400 building inspections

13 dangerous buildings

1,872 meetings with citizens, contractors, etc

919 nuisance's inspections

471 letters to individuals for code violations

6 planning and zoning board meetings

Attends Committee Meetings

1 Administrative Hearing

1,830 pages scanned a year

150+ maps printed
